- > In case of heavy soiling a pre-cleaning with etolit allpurpose cleaner / basic cleaner is recommended.
- > The dosing takes place via an automatic dosing system:
  - etolmat ZDE, etolmat ZDE 1, etolmat ZD 2, etolmat ZDS
- > Add the Doyen F 40 to the water, add surfaces and wipe objects with a damp cloth and use for disinfection let it take effect (note reaction time), not before the end of the exposure time, rinse clearly or dry. Rinse treated surfaces and objects with drinking water before contact with food. Cream dispenser machines: Please note the notes of the device manufacturers
